**Dining Contract
Terms and Conditions**

North Carolina Agricultural and Technical State University seeks to provide dining for all students at the most reasonable rate possible. For this reason, the University operates dining services on a contractual basis for the entire year. It is the meal plan participants' responsibility to become familiar with all provisions of this contract.

Eligibility: Participants must be currently enrolled at North Carolina Agricultural and Technical State University to participate in the meal plan program. Students assigned University housing are required to participate in the meal plan program. It is required for all on campus Freshmen to select Meal Plans A, B or U. **The University will automatically select Meal Plan B for failure to complete a dining contract within five (5) days after University housing is assigned.** Students who are not in University housing are not required to have a meal plan.

Period of Contract: The Dining Contract is for an academic year; billable by semester.

Acceptance: The student accepts the terms and conditions of this contract upon signing of contract and binds the student to the entire contract.

Dining Program:

- A. Unused Flex Dollars are non-transferable from Fall to Spring Semester. Students may eat at any University Dining retail location using Flex Dollars.
- B. Unused Aggie Dining Dollars and Declining balances are transferable from Fall to Spring Semester. All Aggie Dining Dollars and Declining balances must be used by the end of the Spring Semester. Students may eat at any University Dining/Retail location using Aggie Dining Dollars.
- C. All upgrades to meal plans must be made through the Office of Campus Enterprises. All meal plan changes must be done on or before the first day of classes each semester.
- D. Meal Plan cost includes North Carolina sales tax.

Contract Termination by the University: Upon reasonable notice and/or good cause, the University reserves the right to terminate this agreement for failure of the student to abide thereby. Examples of good cause include but are not limited to a change in student status (including academic or disciplinary suspension) and failure to comply with dining policies and regulations, which are hereby contained in this agreement.

Contract Termination by the Student:

- A. Failure to participate in the Dining Program does not and will not automatically release a student from his/her dining contract.
- B. Students assigned housing by the University may terminate this agreement only for one of the following reasons:
 1. Withdrawal from North Carolina A&T State University
 2. Cancellation of the Housing Agreement
 3. Medical conditions (certified by a physician and verified by a Student Health Center Physician)
- C. The last day to change and/or cancel a meal plan is the first day of classes. Any student desiring to terminate the dining contract must provide a written or an email request to:

- D. After the first day of classes; all requests to change and/or cancel a meal plan must be submitted to the Appeals Board at campusent@ncat.edu within five (5) days following the last day to change and/or cancel a meal plan. The Appeals Board will make a decision regarding the request. Failure to submit your written request on time will result in the appeal not being heard or granted. Decisions of the Appeals Board are final. Any refund issued will be pro-rated based upon the date of decision.
